## Expert Workshop on Guidelines for Aquaculture Certification London, UK 28-29 February 2008

## **Background:**

The expert workshop on guidelines for aquaculture certification has been organized by the Food and Agriculture Organization (FAO) in collaboration with the Seafood Choices Alliance, and the Network of Aquaculture Centres in Asia-Pacific (NACA) together with the kind support of the Department for International Development (DFID), in response to the recommendations of the Aquaculture Sub-committee (ASC) of the FAO Committee on Fisheries.

The workshop is the fourth in a series of stakeholder meetings to assist the preparation of international guidelines for aquaculture certification. The three previous aquaculture certification expert workshops have, to date, focussed largely on Asia and Latin America as major producing regions of the world. However, attention is now focused on the major buying regions of the world, namely Europe and the USA. The London workshop will provide the opportunity for dialogue between the guidelines developers, producing country representatives and stakeholders in Europe, predominantly the major retail buyers and processors. The workshop partners will seek views, provide input and hold discussions on the current draft guidelines from a major buyers/retailers perspective and, through the inclusion of representatives of the major producing countries, will seek to explore suitability and across supply chains. A follow-up workshop, similar to this event, will be held in Washington DC in late April 2008.

The workshop will also explore the status, opportunities and mechanisms for enhanced supply chain partnerships to support change, as maybe necessary, to achieve aquaculture certification in producing countries and market access for aquaculture products on the European market.

The guidelines will be submitted, by FAO to its member governments, for approval in October 2008.

## **Workshop Purpose:**

The purpose of the workshop is to gather the views and opinions of European stakeholders involved in aquaculture certification and to continue the process of preparation of the international guidelines for certification of aquaculture products in compliance with the ASC's mandate.

The workshop is also intended to bring together stakeholders across the seafood supply chain to explore opportunities for building partnerships to support the implementation of aquaculture certification in producing countries, with particular reference to the small-scale aquaculture sector.

## **Expected Outputs:**

The expected outputs of the workshop, driven by the discussions and perspectives of the participants, are as follows:

- Stakeholders in Europe will bring together to contribute to the next stage of development of international guidelines for aquaculture certification;
- Aquaculture certification status and potential clarified and key issues and constraints identified for the European region. These key issues and constraints will be elaborated by representatives of supply chain stakeholders including importers, retailers, processors and suppliers from producing countries;
- Further consensus built on the content of the draft international guidelines for certification of aquaculture products;
- To reach an agreement on a continued process of working together amongst stakeholders to develop/complete the guidelines;
- Partnership opportunities, between Europe and other regions, explored regarding the development of mechanisms to support change, increased certification or other outcomes of mutual benefit;
- Improved mutual understanding of the challenges of production, processing and retail roles in an assured supply chain.

## **Workshop Organisation:**

The Workshop will involve 20-30 participants with different perspectives and experience regarding the certification and retail sales of aquaculture products. The workshop discussions will be addressed with a draft set of aquaculture certification guidelines developed from the previous workshops, and selected presentations from participants which will help frame the discussion. All participants will be invited to bring documentation and other pertinent material describing certification programmes, and their experience in aquaculture certification. Presentations should only be used as an information platform. The major part of the workshop will be spent on discussions and working together, towards the further development of the aquaculture certification guidelines and their implementation. The draft programme and preliminary list of background papers are attached hereto.

#### By Car


#### From the A40 (M)
